Zone 1 deliveries using EHD Vehicles are insured up to a value of £2,500 per consignment.

If you require higher levels of insurance cover please make sure that you have arranged this with your own insurer prior to arranging transport with EHD.

Timed deliveries are NOT available in Zone 1.

Pallet deliveries are not offered in Zone 1, all deliveries will be made via a transit sized van.

OTHER UK DELIVERIES - CASE RATES

Zone 2 to 5 orders received before 12:00 noon will be delivered on a 48 hour service.

The only timed delivery option is before noon at an extra cost of £20.00.

All case deliveries to Zones 2 to 5 will be repacked. Each bottle will be placed into Airpacs which will then be placed in strong cartons. This minimises breakages. Should you wish the original packaging to be transported along with the goods then an additional cost will apply.

There may be an additional charge for bottles that do not fit into standard Airpac bags.

OTHER UK CASE DELIVERIES INSURANCE (Ex Zone 1)

It is important to note EHD's liability limits. Each and every claim is subject to a £50 excess. Zone 2 to 5 case deliveries are serviced by our Transport Partners and are only insured up to a value of £100 per consignment.

If you require higher levels of insurance cover please make sure that you have arranged this with your own insurer prior to arranging transport with EHD.

Orders over 4 cases will be sent as a pallet/part pallet at the appropriate rates providing the delivery address is accessible for an HGV vehicle. If there is no available fork lift at the delivery address then a handball charge will apply, this is £12.50 per pallet or part thereof - to the entrance only.

PALLET DELIVERIES

Zone 2 to 4 orders received before 12:00 noon will be delivered on a 48 hour service. Zone 5 orders will be delivered on a 72 hour service.

Delivery address must be accessible for an HGV. Please advise prior to booking the delivery if there are any vehicle size, weight or access restrictions.

Pallet rates are only applicable where the goods are off-loaded by pallet using a fork lift or pallet-truck, if the latter a Tail-Lift must be specified. Cases will not be removed from the pallet unless a 'handball' is specified, the cost of a handball is £12.50 per pallet or part thereof, to the entrance only.

Timed deliveries are available as follows:

Before 9:00, £30.00;

Before noon, £15.00;

At a specified time an additional £20.00.

Next day service £25.00 for the first pallet, £15.00 per pallet for the second and subsequent pallets.

Transport Partners and all goods are carried under the Terms &

Conditions of The Road Haulage Association (2009) which

specifies a limit of £5,000 per 1,000KG pro-rata on insurance claims.

E.g. 160KG of stock maximum claim £800.

If you require higher levels of insurance cover please make sure that you have arranged this with your own insurer prior to arranging transport with EHD.

Please advise prior to booking the delivery if there are any vehicle size, weight or access restrictions.

Pallet deliveries are not offered on Zone 1 deliveries, all Zone 1 deliveries will be made via a transit sized van.

PALLET SIZES

A quarter pallet is up to 250KG, a half pallet 500KG and a full pallet 1,000KG. One case of 12 standard (75cl/70cl) bottles weighs approximately 16KG, however, wooden cases and cases with larger bottles will usually weigh more. A full pallet of standard cases is approximately 60 cases.

One case is up to 12 standard (75cl/70cl) bottles, part cases are charged at the full case rate. Wooden cases may be heavier and therefore subject to higher charges.
